
In pursuance of Circle Office, Mumbai Letter No. AD(R)/Rect/2-9/ MTS Exam/18-19/2019 (Vol III) Dated 9/3/2021, the undersigned is pleased to appoint Shri Nitesh Mohan Kinjalaskar, GDS BPM Miland BO, i/a/w Pachal S.O. provisionally for appointment to the post of Multi Tasking Staff (MTS) who belongs to OBC category and qualified in the competitive examination to the post of MTS from eligible GDS for the vacancy year 2018, 2019 & 2020 held on 11/10/2020 and allotted to Foreign Post Office, Mumbai-400001. The candidate is appointed as Multi Tasking Staff (MTS), in existing vacancies on purely temporary basis with effect from 09/06/2021 in the Pay Band of Rs. 5200-20200 + Grade Pay 1800/- (7th Pay Commission Pay Matrix Level-1) plus allowances as admissible from time to time with immediate effect or from the date of joining.

- The candidate will please note that his appointment as "Multi Tasking Staff" in this department is purely on provisional and temporary basis and his service would be terminated at any time by giving a month's notice in accordance with the provisions of Rule 5 of CCS(T/S) Rules 1965 as amended from time to time in the interest of service.
- It is given to understand that he will be placed on probation for a period of two years (02 years) from the date of joining in MTS cadre. The clearance of probation period will be reviewed by Departmental Promotion Committee after two years. In the event of non satisfactory completion of probation period, he will be discharged from duties and his services will be terminated without assigning any reason.
- The conditions of the service will be governed by the relevant rules and orders in force from time to time.
- The appointment may be terminated by a month's notice in writing by appointing authority. The appointing authority, however reserves the right of terminating the services of the appointee forthwith or before the expiry of stipulated period of notice by making payments to him a sum equivalent to the pay and allowances for the period of notice or un-expired period thereof, if any, if the terms and conditions are not fulfilled.
- The appointment carries with it the liabilities to serve in any part of the circle and in special circumstances, in any part of India. The appointee shall be liable for field service in time of war or national emergencies.
- The seniority of the candidate in the Gradation List will be determined as per rules/Directorate instructions amended/issued from time to time on the subject. He should note that he is expected to serve in this Department as long as he remains in Time Scale of


Pay in which he is appointed and his request for transfer to other Division/Unit before completion of five years service/probation period will not ordinarily be entertained.

8. The candidate is eligible for New Pension Scheme introduced vide Ministry of Finance, Department of Economic Affairs, ECB & PR Division, New Delhi letter no. 5/7/2003-ECB & PR dated 22-12-2003 received under DOP New Delhi letter no. 4-28/2003-Pen dated 01-01-2004 & circulated under C.O. Mumbai letter no. Pen/2-R/New Pension Scheme/11/2004 dated 16-04-2004.

9. The appointment is provisional and subject to verification of the certificates being verified through proper channels. If the verification reveals that the claim of the candidate belonging to Scheduled Caste/Scheduled Tribe/Other backward classes (not belong to creamy layer) is false or, educational certificates are not genuine or found unfit on police verification, his service shall be terminated forthwith without assigning any further reasons and without prejudice to other criminal/legal action as may be taken under the provisions of Indian Penal Code for production of false certificate as a consequence. The candidates belonging to OBC category has to submit current Non Creamy layer Certificate if does not submitted during preliminary verification. This condition also applies to candidates belonging to OBC and selected under OC or UR.

10. It is further given to understand that the appointed candidate is required to perform all duties prescribed for the post of MTS in the Department.
